

CASE NUANCES

Basically, I am writing this piece to indicate some of the truths I have observed and to put some propositions to you.

In the “old days” of a cult many here are familiar with, we had the notion and/or saying regarding being “bigger than your case.”

Some points on this: a) certainly “being bigger than your case” is a key requisite for success in life and the attainment of your Goals, Dreams and Aspirations, b) it is where you end up when you have *fully* handled key areas of your case, c) being accessed and “caved-in” is when the current case scenario is “bigger” and more powerful than you at that time and in that area of your existence, and d) you don’t have to be “bigger than your case” to handle it; you just have to have the courage to address it with the correct technical processes and/or procedures.

So all this raises the question of, “How big is big, and of what?”

Well, as we know from a study of the Earlier Spiritual Domains of Existence (Universes) enjoyed and/or endured by us, in the beginning of our existence before we altered our truth of our Native State of Being, we were infinite and without limit to our Presence.

As Alan has earlier rightly written: “*All of the universes are within you.*”

I have actually found this to be true. The fact is, if we are truly (as we once were) infinite in existence and presence, then there is nowhere else to emanate and locate what we create than **WITHIN THAT INFINITY OF OUR EXISTENCE.**

As I have written before, existing conditions of existence are the result of the continuance of old solutions now running on automatic continuance. And it happens that each of the created new Domains of Spiritual Existence (Universes) were created as solutions to solve the prior Condition of Existence that became untenable.

The current Physical Universe scenario we find ourselves in is at the end of a long, long chain of implemented, lost control of solutions. We have created ourselves into the size and condition of dottedness as a speck within the infinity of existence, reduced to being as a physical life-form, as a human, within the “vastness” of the Physical Universe.

And even there, many are dotted and stuck within their heads.

Today, I am rather more fortunate. In my daily processing sessions I am able to span the record of my temporal existence as I undo the points of change I (with help from others) created to solve earlier unwanted, untenable, scenarios.

That is, I actually span across my entire recorded Time Stream of Existence as I address points of aberration, unlock their impact on our truthful existence and recover truth and my actual powers back to being under my knowing control.

Being able to be “bigger” than the aberrating solution created so long ago helps and enables me to more easily restore and realign the Negative Spiritual Life-Force therein back to Positive and under my present knowing control.

This has not always been the case. There was a time when all I was aware of was the human perspective of being a body.

Now there are nuances to this, which is the reason I am posting this ditty.

Today, when I address any case item to handle it, it is not addressed with me “inside” of it or locked in by it as it was years ago when I began this adventure.

Today when I address any case issue, I address it from the position and condition of being infinite and spanning the entire Time Stream with the “incident” or case item to be handled being a small part and within it.

Now it is true that these case items are not fully opened when I first address them, they appear as though pressing on and impeding me and my awareness. The common theme recently has been that the case item was first perceived to exist, prior to address in session, as being or having a “signature” such as a mood, or condition that was impeding or occluding me.

As an example, the “item” handled this morning (4/7/22) reared its ugly head following yesterday’s session of handling a question in the Presence Three Process handling of an old, old created Identity/Beingness of “A Weak, uncausing, absenced and vanished Beingness.”

Going back a month or so, the case item being handled was “TIREDNESS.” Spiritual tiredness’

Now the particularly interesting thing about it was that at that time, it turned out not to be a single tiredness. As I wrote at the time, I processed the tiredness that I thought had handled that case issue, only to find next day I still had a “tiredness” in the way.

This sequence went on for five days. It turned out that “the” tiredness was actually five separate large incidents of tiredness that, being very similar as to sensation, fused together as though the one instance or event . . . even though each instance or incident had occurred in different Universal Domains of Spiritual Existence along the Time Trail.

Hence, when I processed the “item” that was available on first contact, and it was cleaned up and restored to positive with the relief being such that I felt I had fully handled the issue of feeling of overwhelming tiredness on the case; it turned out I had only handled one of many that had been fused as one.

The result of finally handling all of the incidents of “Tiredness” freed me out into an ascended state of Being.

The next session I did had me processing in the area on a whole “New Area of Case” . . . which revealed its own new Basic Chronic Mood/Condition of UNCONSCIOUSNESS.

Addressing that produced another WOW! which when handled, exposed the Identity/Beingness noted above that I am still processing.

After yesterday’s session (4/8/22) I realized I had ascended up into being able to be at-one with those I was creating to/with. This was a new awareness as prior to yesterday I had been detached, separate and having to project my emanations across a distance to them.

But it was another ascension as this morning (4/9/22) the Basic Chronic Mood/Condition I was sitting in as I looked at my condition and new case scenario was WITHDRAWAL. I was stuck dramatizing and act of withdrawal, and actually mightily experiencing the action of the act.

Needless to say, great wins all about resulted from processing it.

As a final note, you’ll notice the colossal negatives “turned on” following the day before ascension that empowered a comparative positive . . . and all of this nonsense aligns with this ridiculous Weak Identity I have been process for weeks now, as noted above.

Note: what is first available is typically the end of the incident or sequence that is closest to present time from where we are now viewing such.

Related , but different subject, since we were each infinite in our existence, perforce this resulted in our mutual Presence and apparent Unity or “Oneness” of Being. (See Chapter . . .
