

## **ASCENSION STATE HANDLING PROCEDURE**

It is vital that ALL Ascension States are located, handled and stabilized. An Ascension State is often a near or actual re-contact of the Godlike abilities or godlike state of the being.

When a being has an Ascension Experience enormous change takes place, mostly above the being's knowledge level. The basic problem the spiritual being has trouble with is they are subject illiterate. They are so subject illiterate they "do not know they do not know."

The Ascension Experience causes the being to unleash immense potential, but without the needed knowledge. Consequently, the being by-passes a huge amount of wins and regained abilities, failing to fully acknowledge the wins and regained abilities. Often they do not have the nomenclature required to conceptualize and control the regained abilities.

A great amount of vital case and life abilities can be lost at these moments, causing the being to cease progressing from that moment on. Even though the being might appear to make later gains, those gains will keep disappearing as the early Ascension Experience abuses and destabilizes the being's ability to hold a position in regards to the renewed later-regained ability.

**A poorly handled Ascension Experience creates a type of chaotic destructive spiritual case and life holographic disruption sandwich.**

**The sequence is as follows:**

**The basic Ascension Experience, regained states and abilities. — A period of everything appearing to go right. — Then a destabilizing shock. — Then precepts, confusion, charge, losses, upsets, problems and changes. — Then a crash and burn. — The later Ascension Experience, regained states and experience. — Then a destabilizing shock. — Then precepts, confusion, charge, losses, upsets, problems and changes. — Then the present time crash and burn.**

### **THE VITAL TARGET AREA TO PROCESS**

The first area that must be addressed is all earlier processing. Then all earlier training. Then other therapies or practices.

Most Ascension Experiences sit on top of earlier Ascension Experiences. Therefore, as you unburden the Ascension Experience, you must be aware to check for an earlier Ascension Experience. If found, it too must be unburdened.

Educating your client as you go along is vital. (See Ascension Series 2.)

You must be aware of the fact that Ascension Experience and State Handling is a completely NEW technology, representing a huge upward paradigm shift in human potential and transformational rehabilitation. There are no other practices who have the vast comprehension, knowledge, data and scope of procedures needed to stabilize this vital state.

### **LOCATING ASCENSION EXPERIENCE AREAS**

The real skill in processing Ascension Experiences is locating them. The reason an Ascension Experience is sometimes difficult to locate is the great amount of later chaos and loss that have occurred in life and subsequently piled on top of the Ascension Experience and client as a result of failing to fully handle the Ascension Experience. This causes the being to become submerged into their case and fixated inside of their body.

This is gentle processing, a very light touch is needed. You will be amazed at the incredible resurgence in your client's gains, wins and certainty.

### **RECOVERING THE CLIENT'S TIME AND SPACE**

When a client does not handle their Ascension Experience properly, they experience a collapse of time and space. Not firmly grasping what transpired and fully owning the new state, the client returns to their environment and associates. Their environment and associates, not having had an Ascension Experience, will continue to create your client as the way they were. This collapses your client's time and space back to the way it was.

The power of an identity depends entirely on how much time and space it can span and own. The more time and space the spiritual being can own and control, the more powerful, the higher the mood level, the more effective and dynamic the identity.

Therefore, it is extremely important you handle your client's time and space at the moment of the Ascension Experience.

This is done by finding out all that occurred, where it occurred, when it occurred, who was there, how big the room was, what was done, how big the being was, where the being was in relation to their body, the feelings and sensations, etc. You should have a full holographic representation of the Ascension Experience.

When you process this way, your client will make spectacular gains in session and in life.

### **ASCENSION EXPERIENCE HANDLING PROCEDURE**

See Ascension Series 2. If your client has had processing or training, you can substitute question 3 with:

**“In your processing, have you had an Ascension Experience?”**

Or, if your client has only had training ask:

**“In your training, have you had an Ascension Experience?”**

You can substitute for **“an Ascension Experience,”** **“a huge high,”** or **“a big win,”** or **“a big blow out,”** or **“a sense of hugeness.”** You should match your client's reality as close as possible.

When a client goes back into the Ascension Experience the being moves back into the Green Zone. When this occurs the client's ability to come up with the right answers to life and their case soars. Allow your client to tell you what has happened. They will be more right than you can ever hope to be.

The only danger is an area of Subject Illiteracy.

**The area of Subject Illiteracy is what caused the crash and burn in the first place.** So don't be afraid to make your client study the Green Zone and Ascension Series Bulletins.

There are two other key areas that you and the client **MUST** be fully aware of; they are:

1. **Pain.** This includes unpleasant sensations.
2. **Non-permeation.**

I have extensively covered both of these areas in other bulletins.

You should always check each Ascension Experience and ask:

**“Is there an unpleasant sensation?”** Handle accordingly.

**“Is there an area of non-permeation?”** Handle accordingly.

### **CONCENTRATE ON YOUR CLIENT'S STRENGTHS, SUCCESSFUL ACTIONS AND ABILITIES**

The major target of able effective processors and trainers is to reinforce their client's strengths, successful actions and abilities.

Bad practices, processors and trainers concentrate on their client's weaknesses, failures and inabilities. This is a big mistake and causes the client to become totally subjugated to the practice.

With this **NEW** Ascension Experience and State Handling technology, you can really zero in on your client's strengths, successful actions and abilities. An even bigger bonus, you are processing the being's case from the top down.

This **NEW** technology will have a major effect on our future and is a very exciting discovery.
